## CLEAR Pathways to Impact: The Crisis PATHWAYS Response Pilot

The <u>Clear Pathways Crisis Response Pilot</u> explored how local 9-8-8 and 9-1-1 systems could optimally interface to foster coordination and improve care. We based our approach on two core components:

governance and standard operating procedures. We worked with five Ohio communities to advance two primary objectives throughout a 12month pilot:

- 1. Each county established a governance structure, facilitating regular collaboration among key 9-8-8 and 9-1-1 personnel.
- 2. Each county's 9-8-8 call center developed joint policies and procedures with at least one 9-1-1 public safety answering point.

Mathematica's formal evaluation is pending, but preliminary findings were released in 2024. Clear Pathways is sharing the pilot and evaluation results through a series of briefs, webinars, and reports. In response to these findings, we have developed strategy improvements to apply to future pilot sites. By supporting 9-1-1 public safety answering and 9-8-8 call center coordination, we are working to ensure that people experiencing behavioral health crises have a path to help across Ohio and the nation.

## Clear Pathways' 9-1-1 and 9-8-8 Interoperability Strategy

This brief, the first of a three-part series, explores Clear Pathways' 9-1-1 and 9-8-8 Interoperability Strategy and highlights initial findings from the pilot. Staff scanned behavioral health call centers, conducted a 9-1-1 call system assessment, and established core components for successful interoperability. Pilot sites worked to develop procedures for transferring calls from 9-1-1 to 9-8-8. Mathematica evaluated the pilot and has released preliminary findings. Explore the initial findings, strategy improvements, and anticipated site benefits.
